DECLARING CITY ORDINANCE NO. 19-11 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS. PANGASINAN, ENTITLED "AN ORDINANCE DIRECTING ALL BARANGAYS OF SAN CARLOS CITY, PANGASINAN **ESTABLISH** A **BARANGAY MIGRATION** INFORMATION CENTER (MIC) WITHIN RESPECTIVE JURISDICTION" AS WITHIN CONFERRED **POWERS OF** THE **SANGGUNIANG** PANLUNGSOD TO ENACT

**WHEREAS**, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its City Ordinance No. 19-11 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Sections 17 (a); 458 (a) (5) and 394 (d) (6) of RA 7160; and Section 37 of RA No. 7279, known as Urban Development and Housing Act of 1992;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject city ordinance in order;
