APPROVING RESOLUTION NO. 2022-039 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) C.Y. 2022 OF SUAL, PANGASINAN AMOUNTING TO TWENTY-FIVE MILLION PESOS (P25,000,000.00)"

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its SB Resolution No. 2022-039 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sual, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2022, which was endorsed to the Sangguniang Bayan for approval on March 7, 2022 through Resolution No. 2, Series of 2022;
- The Supplemental Investment Program No. 1 of the municipality covers fund augmentation for Maintenance and Other Operating Expenses and Capital Outlay for the Executive Services and implementation of various infrastructure projects and COVID-19 response related activities; and

3. The proposed Supplemental Investment Program has an investment requirement of P25,000,000.00. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 01, CY 2022, which was enacted by their Sangguniang Bayan on March 14, 2022 through Appropriation Ordinance No. 02, Series of 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sual, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—
