APPROVING RESOLUTION NO. 02, S-2019 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED “APPROVING THE ANNUAL INVESTMENT PROGRAM FOR FISCAL YEAR 2019 AND OTHER ACTIVITIES RELATED TO THE ANNUAL BUDGET 2019 IN THE AMOUNT OF P205,731,055.00 AND ASSISTANCE TO MUNICIPALITIES PROGRAM IN THE AMOUNT OF P8,231,000.00 OF THE MUNICIPALITY OF VILLASIS, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Resolution No. 02, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Villasis, Pangasinan has formulated the municipality’s Annual Investment Program for CY 2019 and endorsed thru MDC Resolution No. 04-2018 dated October 1, 2018 to the Sangguniang Bayan for approval. This was subsequently approved by their Sangguniang Bayan thru Resolution No. 02, S-2019 dated July 4, 2019. This is in consonance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Villasis, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic and other service sectors and covers: a) all the regular budgetary requirements for the operation of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction Management Programs/Projects/Activities of the municipality. It also includes the following: 1) Gender and Development Plan, Peace and Order Plan, Local Climate Change Action Plan, and 2) list of programs/projects for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities;

WHEREAS, the AIP has a total investment requirement amounting to P123,962,055.00. Of this, P205,731,055.00 will be funded from the municipality's proposed 2019 Annual Budget which was passed and approved by their Sangguniang Bayan on July 4, 2019 through Appropriation Ordinance No. 01, Calendar Year 2019 while the remaining amount of P8,231,000.00 will be sourced from Assistance to Municipalities Program of the national government;

WHEREAS, the AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the municipality's IRA (P147,491,619.00) which is equivalent to P30,000,000.00 is allocated for development projects.

WHEREAS, the identified development programs/projects to be funded by the 20% of IRA were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the MDRRMC of Villasis has adopted and endorsed thru MDRRMC Resolution No. 1-2018 dated September 25, 2018 to the Sangguniang Bayan for approval the Annual Local Disaster Risk Reduction and Management Fund Investment Plan of the municipality for Calendar Year 2019 amounting to P9,281,302.75. The Sangguniang Bayan approved the Annual LDRRMF Investment Plan thru Resolution No. 03, S-2019 dated July 4, 2019;

WHEREAS, the programs, projects and activities to be funded from the 70% of the 5% LDRRM Fund of the municipality amounting to P6,496,911.92 and the 30% lump sum Quick Response Fund amounting to P2,784,390.83 conforms with Section 21 of RA 10121 and NDRRMC-DBM and DILG Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of Local Disaster Risk Reduction and Management Fund). Further, the LDRRMF Plan of the municipality has been reviewed by the Office of Civil Defense (OCD) in compliance to the Department of Budget and Management as per Local Budget Memorandum No. 77 dated May 15, 2018;

WHEREAS, the LGU has also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in its AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Plan of the municipality was already reviewed by the Department of Interior and Local Government (DILG) and found fully compliant in form and contents with the provisions of the Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG issued on May 17, 2018;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –
