WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 83, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Asingan, Pangasinan has formulated the municipality's Supplemental Annual Investment Program No. 1 and endorsed thru MDC Resolution No. 2, S-2019 dated July 12, 2019. This was approved by their Sangguniang Bayan thru Resolution No. 83, S-2019;

WHEREAS, the Supplemental Investment Program No. 1 of the municipality with an investment requirement amounting to P14,479,748.56 covers fund augmentation for the Personal Services, maintenance and other operating expenses of the executive department and implementation of priority development projects of the municipality;
