RESOLUTION NO. 492-2021

DECLARING ORDINANCE NO. 2021-09 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING THE USE OF PLASTIC BAGS AND POLYSTYRENE FOAM IN THE CITY OF ALAMINOS AND PRESCRIBING PENALTIES THEREFOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT




