RESOLUTION NO. 492-2022

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2022 OF THE CITY OF SAN CARLOS, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P153,239,571.67, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2022 involving total appropriations of P153,239,571.67, which was enacted on January 31, 2022 through Appropriation Ordinance No. 22-01;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
- That the appropriation for BAC Honorarium shall be subject to the provisions of DBM Budget Circular 2004-5A as amended by DBM Budget Circular 2007-3 dated November 29, 2007;

- That the appropriation and disbursement of Additional Election Reserve shall be in accordance with COMELEC Resolution No. 10695 promulgated on February 10, 2021;
- 4. That the purchase of Tractor shall be in accordance with the provisions of DILG Memorandum Circular No. 2021-04 dated January 18, 2021;
- 5. That all programs, projects and activities to be implemented are in accordance with the CY 2022 Supplemental Investment Program of the city; and
- That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the city;

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 01 for Calendar Year 2022 of San Carlos City, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Panlungsod of San Carlos, Pangasinan, for its information and guidance.
