RESOLUTION NO. 493-2019

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2019 OF ASINGAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P14,479,748.56 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2019 involving total appropriations of **P14,479,748.56** which was approved on July 17, 2019 through Appropriation Ordinance No. 1, S-2019;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of RA 7160 and Article 417 (a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;

2. The grant of Performance-Based Bonus (PBB) for CY 2017 to all qualified municipal officials and employees shall be in accordance with the DILG-DBM Joint Memorandum Circular No. 2017-4 specifically Item 8.0 thereof;
3. The purchase of Motor Vehicle shall be in accordance with the provisions of Administrative Order No. 14 dated December 10, 2018, as amended by Administrative Order No. 15 dated May 25, 2011, and DILG Memorandum Circular No. 2014-155 as amended by DILG Memorandum Circular No. 2015-52 dated May 11, 2015, Budget Circular No. 2017-1 dated April 26, 2017 re: Amending Budget Circular No. 2016-5 dated August 22, 2016, and Budget Circular No. 2019-3 dated May 16, 2019;
4. All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2019 Annual/Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007; *and*
5. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the above-findings shall be complied with by the municipality and shall notify the offices concerned of the actions taken thereon;

NOW, THEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN ITS ENTIRETY the Supplemental Budget No. 1 for Calendar Year 2019 of Asingan, Pangasinan** as of the date fixed therein for its effectivity; provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Asingan;




