S-2021 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED **ORDINANCE** DISSOLVING THE **POSITION** ENVIRONMENTAL MANAGEMENT SPECIALIST II IN THE OFFICE OF THE MUNICIPAL MAYOR OF THE LOCAL GOVERNMENT UNIT OF BASISTA" AS WITHIN CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO **ENACT**
