**APPROVING RESOLUTION NO. 38-S-2022 OF THE SANGGUNANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 FOR CY 2022 OF THE MUNICIPALITY OF SAN FABIAN, PANGASINAN AMOUNTING TO TWO HUNDRED EIGHTEEN THOUSAND EIGHT HUNDRED NINETEEN PESOS AND SIXTY CENTAVOS (P218,819.60) FROM THE REVERSION OF APPROPRIATION OF SPECIAL PURPOSE APPROPRIATION"**

**WHEREAS**, the Sangguniang Bayan of San Fabian, Pangasinan submitted its SB Resolution No. 38, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of San Fabian, Pangasinan prepared the LGU's Supplemental Annual Investment Program (SAIP) No. 2 for CY 2022. This was endorsed by the Council, through MDC Resolution No. 02-S. 2022 dated February 7, 2022, to the Sangguniang Bayan for approval;

2. Said Supplemental AIP, which has an investment requirement of ₱218,819.60, covers appropriations for Personal Services for the newly created position (Social Welfare Aide, SG-4) under the Municipal Welfare and Development Office; and
3. Funding for the Supplemental AIP will be sourced from the reversion of Appropriation of Special Purpose Appropriation of the LGU as embodied in their Supplemental Budget No. 1, CY 2022, and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 1, S-2022 dated February 23, 2022.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Fabian, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Jeremy Agerico B. Rosario and Liberato Z. Villegas and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 38-S-2022 of the Sangguniang Bayan of San Fabian, Pangasinan, entitled “Approving Supplemental Annual Investment Program No. 2 for CY 2022 of the Municipality of San Fabian, Pangasinan Amounting to Two Hundred Eighteen Thousand Eight Hundred Nineteen Pesos and Sixty Centavos (P218,819.60) from the Reversion of Appropriation of Special Purpose Appropriation”;
