APPROVING RESOLUTION NO. 2022-04 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "ADOPTING THE SUPPLEMENTAL INVESTMENT PLAN NO. 2022-01 OF THE MUNICIPALITY OF BINALONAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its SB Resolution No. 2022-04 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Section 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Binalonan, Pangasinan had identified items in their Supplemental Annual Investment Program No.1 for CY 2022, which was endorsed to the Sangguniang Bayan for approval on February 4, 2022 through Resolution No. 2022-01;
2. The Supplemental Annual Investment Program No. 1 of the municipality covers fund augmentation for the Construction of Road leading to Goat Dairy Project at Sitio Lubas, Sta. Catalina; and

3. The Supplemental Investment Program No. 1 has an investment requirement of Php2,000,000.00. Funding support for the implementation of the same is embodied in their Supplemental Budget No. 1 CY 2022, which was passed and approved by their Sangguniang Bayan on February 7, 2022 through Appropriation Ordinance No. 2022-01. However, the projects to be funded under the LGU's share from Tobacco Excise Tax amounting to Php2,683,829.00 are already included in the Annual Investment Program CY 2022 and Supplemental Annual Investment Program No. 3 of CY 2021.


