PROVINCIAL RESOLUTION NO. 498-2019

**STRONGLY CONDEMNING THE AMBUSH SHOOTING
AND WOUNDING OF FORMER GOVERNOR AND
CONGRESSMAN AMADO T. ESPINO, JR. AND URGING
THE PHILIPPINE NATIONAL POLICE AND OTHER LAW
ENFORCEMENT AGENCIES TO FAST-TRACK THE
EARLY RESOLUTION OF THE INCIDENT**

WHEREAS, there was an attempt to gun down former Governor and Congressman Amado T. Espino, Jr. perpetrated by unidentified assassins last September 11, 2019 in Barangay Magtaking, San Carlos City, Pangasinan;

WHEREAS, former Governor and Congressman Espino, who sustained injuries from gunshots, survived the ambush but it is saddening, however, that two of his bodyguards were killed and two others were injured;

WHEREAS, the incident is a deplorable act and the perpetrators should be brought to justice;

WHEREAS, the Sangguniang Panlalawigan strongly believes that the ambush is completely unacceptable in a place like the Province of Pangasinan where peace and harmony is presently reigning;

WHEREAS, it is imperative that a speedy and thorough investigation be conducted by the Philippine National Police and other law enforcement agencies in order to determine the motive behind the ambush and identification of the assassins;

WHEREFORE, in view of the foregoing, on motion of Vice Governor Mark Ronald DG. Lambino and co-authored by all Members of the Sangguniang Panlalawigan, duly seconded, it was –
