AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE ATENEO DE MANILA-INSTITUTE OF PHILIPPINE CULTURE AND UNIVERSITY OF THE PHILIPPINES SYSTEM FOR THE IMPLEMENTATION OF AN eHEALTH PROJECT: CAPACITY TO ORGANIZE MASSIVE PUBLIC EDUCATIONAL OPPORTUNITIES IN UNIVERSITIES IN SOUTHEAST ASIA (COMPETEN SEA)

WHEREAS, the Capacity to Organize Massive Public Educational Opportunities in Universities in Southeast Asia (COMPETEN SEA) Project is a capacity building project funded by the European Union-Erasmus that enables the best South East Asian Universities to develop a delivery method for accessible, effective and flexible education and skills development especially in disadvantaged communities more significantly in the goal to raise awareness of Massive Open Online Courses (MOOC);

WHEREAS, the COMPETEN SEA Project is being implemented in the Philippines by the Ateneo de Manila-Institute of Philippine Culture and University of the Philippines System with university partners from Europe;

WHEREAS, the COMPETEN SEA Project aims to provide capacity building inputs to the local government unit to facilitate informed decision making and in support of the Philippine Health Agenda (PHA);


