**RESOLUTION NO. 502-2020**

**DECLARING ORDINANCE NO. 82, S-2020 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING THE POLICIES, RULES AND OPERATION OF TRICYCLES AND PEDICABS IN THE MUNICIPALITY OF LINGAYEN DURING TIMES OF COMMUNITY QUARANTINE AND SIMILAR CIRCUMSTANCES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 82, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (3) (vi) of RA 7160; and consistent with existing guidelines issued by the IATF-EID and the Department of Transportation; and Section 5 (A) (4) of Executive Order No. 0024-2020 of the Province of Pangasinan, as amended;

**WHEREAS**, subject ordinance shall take effect after the Sanggunian has complied with the requirement of posting pursuant to Section 59 (b) of RA 7160;
