RESOLUTION NO. 504-2021

DECLARING ORDINANCE NO. 21-04 OF THE SANGGUNIANG BAYAN OF STA. MARIA, PANGASINAN, ENTITLED "AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE MUNICIPALITY OF STA. MARIA, PANGASINAN IN THE AMOUNT OF TWO HUNDRED FORTY-ONE MILLION PESOS (P241,000,000.00) TO FUND THE VARIOUS PROJECTS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its Municipal Ordinance No. 2021-04 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, the Provincial Planning and Development Coordinator, and the Provincial Accountant have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to 22 (a), (c); 296 (a), (b); 297 (a), (b), and (c); and 444 (b) (vi) of R.A. No. 7160;

WHEREAS, the proposed projects listed in the subject ordinance are not included in the approved Annual Investment Program for CY 2021, thus the LGU should include these projects in their next Supplemental Investment Program;

WHEREAS, the subject ordinance must be pursued in line with the provisions of R.A. No. 7160 which mandates that every loan application must comply with the requirements of the Department of Finance, the Bureau of Local Government Finance (Circular No. 1-2012), and the Bangko Sentral ng Pilipinas (BSP Circular No. 769, S-2012);




