RESOLUTION NO. 506-2022

DECLARING MUNICIPAL ORDINANCE NO. 03, S-2022 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING ONE (1) PARCEL OF LAND DESCRIBED AS: LOT NO. 6022-P CONTAINING AN AREA OF FIVE THOUSAND SQUARE METERS (5,000 SQ. M.) COVERED BY TCT NO. 8775-P WITH TAX DECLARATION NO. 01263 SITUATED IN BARANGAY BAYAMBANG, INFANTA, PANGASINAN FROM AGRICULTURAL LAND TO COMMERCIAL LAND" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Municipal Ordinance No. 03, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Provincial Planning and Development Coordinator, and Department of Human Settlements and Urban Development Regional Director have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 and 447 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, the Municipality of Infanta has an existing Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2017-2026;

WHEREAS, Clearance for Reclassification (Certification) from the Department of Agrarian Reform has been secured however, the same clearance from the Department of Agriculture must also be secured and submitted to the Sangguniang Panlalawigan before the subject ordinance will be implemented;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 03, S-2022 of the Sangguniang Bayan of Infanta, Pangasinan, entitled “An Ordinance reclassifying one (1) parcel of land described as: Lot No. 6022-P containing an Area of Five Thousand Square Meters (5,000 SQ. M.) covered by TCT No. 8775-P with Tax Declaration No. 01263 situated in Barangay Bayambang, Infanta, Pangasinan from agricultural land to commercial land” as within the conferred powers of the Sanggunian to enact;

RESOLVED FURTHER, that a copy of this resolution be furnished to the Office of the Sangguniang Bayan of Infanta, Pangasinan, for its information and guidance.
