APPROVING RESOLUTION NO. 237, S-2020 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN FUNDED UNDER SUPPLEMENTAL BUDGET NO. 1 FOR CY 2020 AMOUNTING TO SIXTEEN MILLION TWO HUNDRED EIGHTY TWO THOUSAND FOUR HUNDRED SEVENTY THREE PESOS (P16,282,473.00)"

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 237, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Bautista, Pangasinan has adopted and endorsed the municipality's Supplemental Annual Investment Program No. 1 through MDC Resolution No. 01, S-2020 dated February 24, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on March 23, 2020 through Resolution No. 237, S-2020. This is in pursuance to Sections 106, 109, and 114 of RA 7160;

WHEREAS, the Supplemental Annual Investment Program No. 1 with an investment requirement amounting to P16,282,473.00 covers fund augmentation for the personal services, maintenance and other operating expenses, requirement of the various municipal government offices, implementation of development and disaster risk reduction management programs/activities of the municipality;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
