WHEREAS, the vaccination registry app is an online registration platform that would ensure a smooth rollout of COVID-19 vaccines in the Province;

WHEREAS, the establishment of a vaccination registry app is a tool that would provide a more efficient and effective listing, cueing and identification for COVID-19 vaccine recipients in the Province of Pangasinan;

WHEREAS, the use of vaccination registry app would avoid walk-in registration thereby lessening interaction and usage of any object that may cause contagion of the virus;

WHEREAS, the vaccination registry app would hasten easier tabulation, tracing and record keeping of information of registrants;

WHEREAS, the use of vaccination registry app would complement the objective of the implementation of health and safety protocols in the Province;

WHEREAS, the Sangguniang Panlalawigan earnestly requests the establishment of a vaccination registry app for the Province of Pangasinan;
