DECLARING ORDINANCE NO. 109, S-2022 OF THE SANGGUNIANG BAYAN OF LINGAYEN. PANGASINAN. ENTITLED "AN ORDINANCE PROHIBITING GENDER-BASED SEXUAL HARASSMENT IN STREETS AND PUBLIC SPACES IN MUNICIPALITY OF LINGAYEN, PROVINCE OF PANGASINAN, PROVIDING THE GUIDELINES IN THE **IMPLEMENTATION THEREOF** AND **PRESCRIBING** PENALTIES FOR VIOLATIONS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 109, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, subject ordinance shall take effect after compliance with the requirement of posting and publication pursuant to Sections 59 (c) and 511 (a) of R.A. 7160;
