URGING THE COMMITTEE ON INFRASTRUCTURE, PUBLIC SERVICES AND UTILITIES TO CONDUCT A COMMITTEE HEARING, IN AID OF LEGISLATION, ON THE STATUS OF WATER SYSTEM PROJECTS OF PRIME WATER INFRASTRUCTURE CORPORATION WITH THE DIFFERENT LOCAL GOVERNMENT UNITS IN THE PROVINCE OF PANGASINAN
