APPROVING RESOLUTION NO. 374, S-2017 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 2 FOR CALENDAR YEAR 2017 TO BE FUNDED FROM BURLEY AND NATIVE TOBACCO EXCISE TAX PURSUANT TO REPUBLIC ACT NO. 8240 AS AMENDED BY RA 10351"

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Resolution No. 374, Series of 2017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Bayambang, Pangasinan has prepared the municipality's Supplemental Annual Investment Program No. 2 CY 2017 to be funded from the municipal share/collection of Excise Tax from Burley and Native Tobacco amounting to a total of P3,157,426.00. This was endorsed by Municipal Development Council thru MDC Resolution No. 11-006, S-2017 dated November 28, 2017 to the Sangguniang Bayan for approval;
