**APPROVING RESOLUTION NO. 14, S-2019 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 1 CY-2019 OF THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Resolution No. 14, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Mapandan, Pangasinan has prepared the municipality’s Supplemental Annual Investment Program No. 1 for CY 2019. This was endorsed by the Council thru MDC Resolution No. 01, S-2019 dated July 31, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 14, S-2019 dated August 2, 2019;

**WHEREAS**, the Supplemental Annual Investment Program of the municipality which has a total investment requirement of P3,829,090.96, covers augmentation funds for Personal Services (step increment of some municipal officials, monetization of vacation leave credits, wages of contract of service for the operation of public market and slaughterhouse), MOOEs, Capital Outlay and other special purpose appropriations;
