URGING THE SECRETARY OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS TO CAUSE THE RECLASSIFICATION OF THE PROVINCIAL ROADLINE FROM BARANGAY TALOGTOG IN POZORRUBIO, PANGASINAN TO BARANGAY PAO IN MANAOAG, PANGASINAN INTO A NATIONAL ROAD

**WHEREAS**, the Manaoag-Pozorrubio Provincial Roadline is one of the more important thoroughfares in the Province of Pangasinan;

**WHEREAS**, the Manaoag-Pozorrubio Provincial Roadline is a vital artery connecting central and eastern portions of Pangasinan;

**WHEREAS**, the Manaoag-Pozorrubio Provincial Roadline is being utilized daily by the riding public especially the hundreds of pilgrims that visit the Municipality of Manaoag;
