APPROVING RESOLUTION NO. 218, S-2017 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF CALASIAO FOR THE YEAR 2017"

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 218, Series of 2017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Calasiao, Pangasinan has formulated the municipality's Supplemental Annual Investment Program for CY 2017 to be funded from the General Fund (additional revenues, income, loan and savings from unfilled/vacant positions). This was endorsed by the Council thru MDC Resolution No. 5, S-2017 dated October 6, 2017 to the Sangguniang Bayan;

**WHEREAS**, the Sangguniang Bayan approved said endorsement thru SB Resolution No. 218, S-2017 dated October 12, 2017;

**WHEREAS**, the Supplemental Annual Investment Program (SAIP) of the municipality covers augmentation fund for Personal Services, MOOE and Capital Outlay of various offices of the LGU, to include GAD and MDRRM-related activities, and implementation of other development projects;

**WHEREAS**, the SAIP of the municipality has an investment requirement of P25,303,394.05. Funding for the full implementation of said SAIP is embodied in the municipality's Supplemental Budget No. 02, FY 2017 thru Appropriation Ordinance No. 08, S-2017 dated October 12, 2017;

**WHEREAS**, it is recommended, however, that 30% (P32,669.40) of the additional 5% MDRRMF (P108,898.00) will be set aside as Quick Response Fund as per Section 4.0 of the MDRRMC-DBM-DILG Joint Memo Circular No. 2013-1 dated March 26, 2013;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Angel M. Baniqued, Jr. and Generoso D. Tulagan, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia and Jeanne Jinky C. Zaplan, duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 218, S-2017 of the Sangguniang Bayan of Calasiao, Pangasinan, entitled "Approving the Supplemental Annual Investment Program (AIP) of the Municipality of Calasiao for the year 2017";
