#### **RESOLUTION NO. 523-2020**

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2020 OF LINGAYEN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P65,571,739.10 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2020 involving total appropriations of **P65,571,739.10** which was approved on April 20, 2020 through Appropriation Ordinance No. 1, S-2020;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

- 1. The full implementation of the First Tranche Salary Adjustment for municipal officials and employees shall be in accordance with the provisions of Local Budget Circular No. 121 of the Department of Budget and Management dated January 24, 2020: Re: Implementation of the First Tranche of the Modified Salary Schedule for Local Government Personnel Pursuant to Republic Act No. 11466;
- The grant of Hazard Pay to government personnel who physically report for work during the period of implementation of an Enhanced Community Quarantine relative to the COVID-19 Outbreak shall be in accordance with the provisions of Administrative Order No. 26 by the President of the Philippines dated March 23, 2020 and Budget Circular No. 2020-1 dated March 24, 2020;

- 3. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
- The grant and disbursement of Special Risk Allowance (SRA) to frontline Public Health Workers of the Municipality shall be subject to DBM Budget Circular No. 2020-2 dated April 7, 2020;
- The appropriation and utilization of the Bayanihan Grant to Cities and Municipalities shall be in accordance with the Local Budget Circular No. 125 dated April 7, 2020; and
- 6. All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2020 Annual/Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**NOW, THEREFORE**, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN ITS ENTIRETY the Supplemental Budget No. 1 for Calendar Year 2020 of Lingayen, Pangasinan** as of the date fixed therein for its effectivity; provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Lingayen;

**RESOLVED FURTHER**, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Lingayen, Pangasinan, for its information and guidance.
