DECLARING MUNICIPAL ORDINANCE NO. 007-2021 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE NEW PERMANENT POSITIONS IN VARIOUS OFFICES IN THE MUNICIPAL GOVERNMENT OF MALASIQUI, AS FOLLOWS: ACCOUNTANT III, SG 18, OFFICE OF THE MUNICIPAL ACCOUNTANT AND SENIOR ADMINISTRATIVE ASSISTANT II, SG 14 (COMPUTER OPERATOR) IV OFFICE OF THE MUNICIPAL ASSESSOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its Municipal Ordinance No. 007-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76, 447 (a) (1) viii) of R.A. No. 7160;

WHEREAS, however, the salary grade allocation of Accountant III should be adjusted from SG-18 to SG-19 pursuant to Annex "B" of Budget Circular No. 2009-92 dated September 3, 2009 (Re-allocated Classes of Positions);
