### APPROVING SB RESOLUTION NO. 18, S-2021 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED "RESOLUTION APPROVING THE RESOLUTION NO. 2, S-2021 OF THE SAN QUINTIN DEVELOPMENT COUNCIL'S EXECUTIVE COMMITTEE ON THE REVISED ANNUAL INVESTMENT PROGRAM CY 2021 INTEGRATING THE CY 2020 QUICK RESPONSE'S PROGRAMS, ACTIVITIES AND PROJECTS (PPAs)"

**WHEREAS**, the Sangguniang Bayan of San Quintin, Pangasinan submitted its SB Resolution No. 18, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Local Disaster Risk Reduction and Management Council, in its Resolution No. 1, Series of 2021 dated February 22, 2021, has recommended supplementary/new DRRM programs/projects to be funded by the savings from LDRRMF CY 2020 Quick Response Fund in the amount of Php3,146,883.02 and to be incorporated in the Annual Investment Program for CY 2021;

WHEREAS, the CY 2021 Annual Investment Program of the Municipality of San Quintin was revised to include the LDRRM programs and projects in response to COVID-19 pandemic which will be funded from CY 2020 Reserves/Savings LDRRMF amounting to Php3,146,883.02. This is in accordance with Section 2.5.6 of Local Budget Circular No. 124 dated March 26, 2020. This was endorsed to the Sangguniang Bayan by the Municipal Development Council through MDC Executive Committee Resolution No. 2, Series of 2021 dated February 26, 2021;
