APPROVING RESOLUTION NO. 2020-042 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL AIP PURSUANT TO APPROPRIATION ORDINANCE NO. 2020-001 OF THE MUNICIPALITY OF TAYUG, PANGASINAN INVOLVING AN AMOUNT OF THREE MILLION EIGHTY FOUR THOUSAND SIX HUNDRED FIFTY FIVE AND 58/100 (P3,084,655,58)"

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Resolution No. 2020-042 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Tayug, Pangasinan has formulated and endorsed the municipality's Supplemental Investment Program No. 1 through MDC Resolution No. 2020-02 dated February 7, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on February 18, 2020 through Resolution No. 2020-042. This is in pursuance to Sections 106, 109, and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 1 with an investment requirement amounting to P3,084,655.58 covers the implementation of salary increase of municipal officials and employees;
