DECLARING REVISED MUNICIPAL ORDINANCE NO. 2017-05 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "AN ORDINANCE ADOPTING THE TRAFFIC CODE FOR PUBS, PUJS, PUVS, PUTS, MOTORCYCLES AND ALL TYPES OF VEHICLES IN THE MUNICIPALITY OF BUGALLON, PANGASINAN AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Revised Municipal Ordinance No. 2017-05 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii), (5) (v) and (vi) of RA 7160;

WHEREAS, subject ordinance shall take effect after the publication requirement has been complied with by the Sangguniang Bayan of Bugallon, Pangasinan;
