DECLARING ORDINANCE NO. 127, S-2020 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING ONE (1) POSITION OF HUMAN RESOURCE MANAGEMENT OFFICER II UNDER THE OFFICE OF THE MAYOR OF THE LOCAL GOVERNMENT UNIT OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 127, S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of RA 7160;

WHEREAS, the position title of Human Resource Management Officer II, Salary Grade 15 under the Office of the Mayor should be changed to Administrative Officer IV, Salary Grade 15 to conform with the provisions of Budget Circular No. 2004-3 dated March 6, 2004 entitled "Conversion of Position Performing Staff/Non-Technical Functions";
