RESOLUTION NO. 535-2020

DECLARING ORDINANCE NO. 065-2020 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING THE MANDATORY USE OF FACE MASKS AND STRINGENT PRACTICE OF PHYSICAL DISTANCING BY ALL PERSONS WHO ARE FOUND IN THE MUNICIPALITY OF LABRADOR DURING THE ENHANCED COMMUNITY QUARANTINE AND ANY EXTENSION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Ordinance No. 065-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 16 of RA 7160; DILG Memorandum Circular No. 2020-071 (Mandatory Wearing of Face Masks or Other Protective Equipment in Public) and Provincial Ordinance No. 235-2020 (An Ordinance Requiring the Mandatory Wearing of Face Masks by all Persons in Public Places Within the Territorial Jurisdiction of the Province of Pangasinan During the Period of Enhanced Community Quarantine and For Any Extension Thereof);

WHEREAS, however, the Sanggunian shall consider the observations of the Provincial Legal Officer in her opinion dated May 29, 2020;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 065-2020 of the Sangguniang Bayan of **Labrador**, Pangasinan, entitled "An Ordinance requiring the mandatory use of face masks and stringent practice of physical distancing by all persons who are found in the Municipality of Labrador during the Enhanced Community Quarantine and any extension thereof" as within the conferred powers of the Sangguniang Bayan to enact;
