APPROVING RESOLUTION 22. S-2020 **OF** THE SANGGUNIANG BAYAN PANGASINAN, CALASIAO, **ENTITLED** "APPROVING MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 1, S-2020 ENTITLED "RESOLUTION RECOMMENDING THE APPROVAL OF REALIGNMENT/REVERSION OF THE AMOUNT OF P9,500,000.00 FROM THE PORTION OF THE 20% DEVELOPMENT FUND OF THE 2020 ANNUAL INVESTMENT PROGRAM FOR PURPOSES OTHER THAN THOSE STIPULATED"

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 22, S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Calasiao, Pangasinan has recommended to their Sangguniang Bayan the realignment/reversion of the sum of P9,500,000.00 from their 20% Development Fund/Loan Amortization Savings (2020 Annual Investment Program). This was endorsed by the Council, through MDC Resolution No. 1, S-2020 dated February 24, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Sangguniang Bayan approved said recommendation/endorsement through Sangguniang Bayan Resolution No. 22, S-2020 dated March 2, 2020;
