APPROVING RESOLUTION NO. 2021-125 **OF** THE P SANGGUNIANG OF MANGALDAN, PANGASINAN. "APPROVING **ENTITLED** AND ADOPTING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 2, CY 2021 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its SB Resolution No. 2021-125 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Municipal Development Council of Mangaldan, Pangasinan prepared the LGU's Supplemental Investment Program No. 2 for CY 2021. This was endorsed to the Sangguniang Bayan of Mangaldan by the Council through MDC Resolution No. 2, Series of 2021 dated April 23, 2021;

WHEREAS, said Supplemental AIP which has a total investment requirement of P152,726,374 .00 covers the implementation of priority infrastructure projects of the LGU;

WHEREAS, funding for the Supplemental AIP will be sourced from the loan of the LGU from the Land Bank of the Philippines, in the amount of P150,000,000.00, as embodied in the LGU's Supplemental Budget No. 2, CY 2021 which was enacted by the Sangguniang Bayan through Appropriation Ordinance No. 2021-05 dated May 14, 2021;

WHEREAS, the remaining P2,726,374.00 will be derived from the Municipal Share from the collections of Burley and Native Tobacco Excise Tax for CY 2017;

WHEREAS, the Sangguniang Panlawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Jeremy Agerico B. Rosario and Liberato Z. Villegas and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –
