**RESOLUTION NO. 537-2022**

**DECLARING MUNICIPAL ORDINANCE NO. 02-2022 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE DECLARING MAY 10, 1859 AS THE OFFICIAL FOUNDATION DAY OF THE MUNICIPALITY OF ANDA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Anda, Pangasinan submitted its Ordinance No. 02-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (6)) of R. A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 02-2022 of the Sangguniang Bayan of Anda, Pangasinan, entitled "An Ordinance declaring May 10, 1859 as the Official Foundation Day of the Municipality of Anda, Pangasinan" as within the conferred powers of the Sanggunian to enact;






