**RESOLUTION NO. 538-2021**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CY 2021 OF MANGALDAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P150,000,000.00 OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2021 involving total appropriations of P 150,000,000.00 which was approved on May 14, 2021 through Appropriation Ordinance No. 2021-05;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the funding sources of the subject Supplemental Budget were determined in accordance to Section 321 of R.A. No. 7160 and Article 414 (a) of its Implementing Rules and Regulations (IRR) as amended by Administrative Order No. 47 dated April 12, 1993;

2. That the total fund source available for supplemental appropriations (i.e. Proceeds from Loan from the Land Bank of the Philippines (LBP) will be made actually available as required under Article 417 (a) of the IRR of R.A. No. 7160, as amended by Administrative Order No. 47, and as contained in the Omnibus Term Loan Agreement between the LBP and the Municipal Government of Mangaldan;

3. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2021 Annual/Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2017, dated March 8, 2007;

4. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its implementing rules and regulations;

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**NOW THEREFOR**, in view of the foregoing, on motion of SP Members Jeremy Agerico B. Rosario and Liberato Z. Villegas and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –


