## **RESOLUTION NO. 539-2022**

DECLARING ORDINANCE NO. 22-02 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "AN ORDINANCE AUTHORIZING THE HONORABLE JULIER C. RESUELLO, IN HIS CAPACITY AS THE CITY MAYOR OF SAN CARLOS CITY (PANGASINAN), TO ALLOW THE USE OF A CITY GOVERNMENT PROPERTY LOCATED AT BARANGAY TARECTEC AS HOUSING SITE FOR IDENTIFIED QUALIFIED BENEFICIARIES OF THE SAN CARLOS PLAINS-HOUSING PROJECT" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 22-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Section 17 (b) (3) (viii) (4) and Section 18 of R. A. No. 7160, and is likewise consistent to Section 21 of R.A No. 7279 otherwise known as the "Urban Development and Housing Act of 1992";

WHEREAS, subject ordinance shall take effect after compliance with the requirement of posting pursuant to Section 59 (c) R.A. 7160;
