DECLARING MUNICIPAL ORDINANCE NO. 125, S-2022 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "AMENDING SECTIONS 1, 2, AND 3 OF MUNICIPAL ORDINANCE NO. 120, S. 2021" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Ordinance No. 125, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
