**RESOLUTION NO. 545-2022**

**DECLARING MUNICIPAL ORDINANCE NO. 125, S-2022 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "AMENDING SECTIONS 1, 2, AND 3 OF MUNICIPAL ORDINANCE NO. 120, S. 2021" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Ordinance No. 125, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 447(a) (5) (vii) of R.A. No. 7160;




