DECLARING MUNICIPAL ORDINANCE NO. 2018-02 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "AN ORDINANCE ENACTING THE 2018 MARKET CODE OF THE MUNICIPALITY OF BUGALLON, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Municipal Ordinance No. 2018-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer and the Provincial Treasurer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (3) (i) and (iii), and (5) (ii) of RA 7160;

WHEREAS, subject ordinance shall take effect after the posting and publication requirements pursuant to Sections 59 and 522 of RA 7160 are complied with by the Sangguniang Bayan of Bugallon, Pangasinan;
