PROVINCIAL RESOLUTION NO. 549-2019

URGING THE PROVINCIAL GOVERNMENT OF PANGASINAN THROUGH GOVERNOR AMADO I. ESPINO III TO CAUSE THE PURCHASE OF POLYMERASE CHAIN REACTION TEST (PCR) MACHINE TO BE USED BY THE PROVINCE

WHEREAS, the African Swine Fever (ASF) is a viral disease transmitted to swine that is presently causing major economic loss to hog industry in some areas of the country;

WHEREAS, Pangasinan was not spared from the effect of ASF despite the prohibition of the entry of infected swine from other provinces into the Province to prevent the possible spread of the same;

WHEREAS, the Polymerase Chain Reaction (PCR) can be used for ASF detection, and diagnosis of the infectious disease can be determined in a short period of time;

WHEREAS, there is a need therefore for the Province to purchase a Polymerase Chain Reaction which can be used for veterinary services for effective monitoring of ASF to contain, eliminate and prevent further spread of the disease;

NOW, THEREFORE, in view of the foregoing, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to urge, as it is hereby urged, the Provincial Government of Pangasinan through Governor Amado I. Espino III to cause the purchase of Polymerase Chain Reaction (PCR) Machine to be used by the Province;




