PROVINCIAL RESOLUTION NO. 549-2022

AUTHORIZING THE GRANT OF FINANCIAL ASSISTANCE TO ALL JOB ORDER EMPLOYEES/CONTRACT OF SERVICE EMPLOYEES/CONSULTANTS IN THE PROVINCIAL GOVERNMENT OF PANGASINAN WHICH SOURCE OF FUND AS INDICATED IN SUPPLEMENTAL BUDGET NO. 4, SERIES OF 2022

WHEREAS, Section 468 (a) (1) (viii) of RA 7160, otherwise known as the Local Government Code of 1991 provides that the Sangguniang Panlalawigan has the power to determine the positions and salaries, wages, allowances and other emoluments and benefits of employees of the provincial government;

WHEREAS, DBM Budget Circular No. 2017-2 dated May 8, 2017 grants Mid-Year Bonus to government personnel for FY 2017 and years thereafter except for consultants/job orders/contract of service employees;

WHEREAS, the Provincial Government and its Officials find it meritorious to reward also, as a token of their dedicated service, all job order employees/contract of service employees/consultants for their unprecedented efforts and assistance in making Pangasinan always No. 1 in terms of public and civil service;

WHEREAS, likewise, the provincial government has appropriated for them funds in the form of financial assistance to help them shoulder their expenses during this period of public health crisis;

WHEREAS, the grant of financial assistance, however, shall depend on their length of service as of April 30, 2022 such as those who have rendered service for at least four months are entitled to P4,000.00, P3,000.00 for 3 months, P2,000.00 for 2 months and P1,000.00 for one month;




