APPROVING RESOLUTION NO. 34, S-2021 **OF SANGGUNIANG BAYAN** OF VILLASIS, PANGASINAN. ENTITLED "APPROVING THE ANNUAL LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (ALDRRMFIP) FOR CALENDAR YEAR 2022 IN THE AMOUNT OF FOURTEEN MILLION TWO HUNDRED TWENTY THOUSAND FOUR HUNDRED THIRTY PESOS (P14,220,430.00) OF THE MUNICIPALITY OF VILLASIS, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its SB Resolution No. 34, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Municipal Disaster Risk Reduction and Management Council of Villasis has adopted the Annual Local Disaster Risk Reduction and Management Fund Investment Plan (ALDRRMFIP) of the municipality for calendar year 2022 and endorsed to the Sanggunian Bayan for approval thru MDRRMC Resolution No. 01-2021 dated August 3, 2021;

WHEREAS, the programs/projects/activities embodied in the ALDRRMF Investment Plan were integrated in the AIP 2022 of the municipality. This is in conformity with Section 6.2 of the NDRRMC-DBM-DILG JMC 2013-1. Further, the programs/projects/ activities to be funded from the 70% of the 5% LDRRM Fund (Php14,220,430.00) amounting to Php9,954,300.00 and the 30% lump sum Quick Response Fund amounting to Php4,266,130.00 conforms with Section 21 of RA 10121 and NDRRMC-DBM-DILG Joint Memo-Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of Local Disaster Risk Reduction and Management Fund). Also, the LDRRM Plan 2019-2024 of the municipality was reviewed and evaluated by

the Office of the Civil Defense Regional Office 1 (OCD RO-1) Regional Assessment Team and a certification dated July 14, 2020 was issued to the LGU of Villasis, Pangasinan;
