**PROVINCIAL RESOLUTION NO. 553-2019**

**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO SIGN THE AMENDMENT LETTER TO THE MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE BUSINESS FOR SOCIAL PROGRESS, INC. FOR THE IMPLEMENTATION OF THE GLOBAL FUND PROJECT CALLED “INTENSIFYING AND MAINSTREAMING INTEGRATED DOTS IN THE PHILIPPINES”**

**WHEREAS**, received by the Sangguniang Panlalawigan for appropriate action is a letter dated August 28, 2019 of Dr. Anna Ma. Teresa S. de Guzman, Provincial Health Officer II, requesting for the passage of a resolution authorizing Governor Amado I. Espino III to sign an amendment letter on behalf of the Provincial Government of Pangasinan with the Philippine Business for Social Progress, Inc.;

**WHEREAS**, pursuant to Provincial Resolution No. 10-2019 of the Sangguniang Panlalawigan, a Memorandum of Agreement was entered into and signed by the Province of Pangasinan with the Philippine Business for Social Progress, Inc. for the implementation of the Programmatic Management of Drug-Resistant Tuberculosis Project in the Province;

**WHEREAS**, the Province of Pangasinan, through its public health facilities, namely: Pangasinan Provincial Hospital, Urdaneta District Hospital, Eastern Pangasinan District Hospital, Western Pangasinan District Hospital and Bayambang District Hospital, has been the implementing partners of the Department of Health in order to effectively and efficiently deliver quality clinical and laboratory services among tuberculosis patients covered by the Global Fund Project;

**WHEREAS**, there is a need to amend the Memorandum of Agreement to conform with Republic Act No. 10173 or the “Data Privacy Act of 2012”;
