RESOLUTION NO. 553-2022

DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2022 OF THE CITY OF SAN CARLOS, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P10,500,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2022 involving total appropriations of P10,500,000.00, which was enacted on March 14, 2022 through Appropriation Ordinance No. 22-04;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

- 2. That the appropriation for the implementation of the Third Tranche compensation adjustments shall be subject to the provisions of Local Budget Circular (LBC) No. 143 dated January 3, 2022, re" Implementation of the Third Tranche of the Modified Salary Schedule for Local Government Personnel Pursuant to Republic Act RA) No. 11466"; and
- 3. That the appropriation for the payment of Monetization of Leave Credits shall be subject to the provisions of DBM Budget Circular No. 2016-2 dated March 29, 2016 re "Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits", which provides for the new constant factor stated under Item 3. 1 thereof.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the city;

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 2 for Calendar Year 2022 of San Carlos City, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Panlungsod of San Carlos, Pangasinan, for its information and guidance.
