DECLARING MUNICIPAL ORDINANCE NO. 2022-03 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING THE MUNICIPAL INCIDENT COMMAND SYSTEM (MICS) IN THE MUNICIPALITY OF MANGALDAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Ordinance No. 2022-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iv) (vii) of R. A. No. 7160 and Rule 7, Section 3 (h) of the Implementing Rules and Regulations of Republic Act No. 10121, otherwise known as Philippine Disaster Risk Reduction and Management Act of 2010;

WHEREAS, subject ordinance shall take effect after compliance with the requirement of posting pursuant to Section 59 (c) R.A. 7160;
