APPROVING RESOLUTION NO. 2022-09 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED "APPROVING THE 2022 SUPPLEMENTAL INVESTMENT PLAN (SIP) OF THE MUNICIPALITY OF SAN MANUEL, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its SB Resolution No. 2022-09 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- On February 4, 2022, the Local Development Council of San Manuel, Pangasinan has identified programs/projects to be funded from the CY 2019 municipality's share from Tobacco Excise Tax. These are embodied in the Supplemental Investment Plan (SIP) No. 2 of San Manuel, Pangasinan which was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 02, S-2022;
- 2. The Supplemental Investment Plan No.2 with a total investment requirement amounting to Php6,216,283.00 covers the implementation of programs, projects and activities that are consistent with Local Budget Memorandum Nos. 83 & 84, both dated November 22, 2021; and

3. On February 9, 2022, the Sangguniang Bayan enacted Supplemental Budget No. 2 through Appropriation Ordinance No. 02, S-2022 to support the implementation of the said Supplemental Investment Plan of the municipality.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Manuel, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Salvador S. Perez, Jr. and Noel C. Bince and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—
