AUTHORIZING THE REVERSION OF OBLIGATED AMOUNTS IN WHICH NO LIABILITY HAS BEEN RECOGNIZED FOR THE YEAR ENDED DECEMBER 31, 2021 OF THE PROVINCIAL GOVERNMENT TO UNAPPROPRIATED SURPLUS PURSUANT TO SECTIONS 322 AND 328 OF RA 7160

WHEREAS, based on the records of the Provincial Accounting Office as of May 16, 2022, the Provincial Government of Pangasinan has existing obligated amounts in which no liability has been recognized for the year ended December 31, 2021 amounting to **P7,500,000.00**;

WHEREAS, these obligations may be reverted to unappropriated surplus pursuant to Sections 322 and 328 of RA 7160;

WHEREAS, the Provincial Accounting Office scrutinized available records and found out that the amount of **P7,500,000.00** is available for reversion to date;

NOW, THEREFORE, on motion of SP Members Angel M. Baniqued, Jr. and Jeremy Agerico B. Rosario, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan of Pangasinan in session assembled to authorize, as it is hereby authorized, the reversion of obligated amounts in which no liability has been recognized for the year ended December 31, 2021 of the Provincial Government to unappropriated surplus pursuant to Sections 322 and 328 of RA 7160;


