APPROVING SB RESOLUTION NO. 045-2020 OF THE SANGGUNIANG **BAYAN OF** MALASIQUI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT **PROGRAM NO. 01-2020 OF THE MUNICIPALITY OF MALASIQUI,** PANGASINAN IN THE AMOUNT OF TWENTY-FIVE MILLION **ONE HUNDRED ELEVEN THOUSAND SIXTY-ONE PESOS** (P25,111,061.00)"

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its SB Resolution No. 045-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Malasiqui, Pangasinan prepared the Supplemental Annual Investment Program (AIP) No. 01-2020. This was endorsed by the Council, through MDC Resolution No. 01-2020 dated April 14, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 045-2020 dated April 15, 2020;

WHEREAS, said Supplemental Annual Investment Program, which has a total investment requirement of P25,111,061.00, is intended to finance procurement of Personal Protective Equipment (PPE), Equipment, Reagents, and Kits for COVID-19 Testing, Medicines and Vitamins, Hospital Equipment and Supplies, Provision of Food, Transportation (including fuel) and Accommodation Expenses, Food Assistance and Procurement of Relief Goods, and other necessary COVID-19 related programs, projects and activities of the LGU;

WHEREAS, funding for this Supplemental AIP will be sourced from the Bayanihan Grant to Cities and Municipalities (as per Local Budget Circular No. 125 dated April 7, 2020) of the LGU as embodied in their Supplemental Budget No. 1, FY 2020, and approved by their Sangguniang Bayan through Appropriation Ordinance No. 001-2020 dated April 15, 2020;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 045-2020 of the Sangguniang Bayan of **Malasiqui**, Pangasinan, entitled "Approving the Supplemental Investment Program No. 01-2020 of the Municipality of Malasiqui, Pangasinan in the amount of Twenty-Five Million One Hundred Eleven Thousand Sixty-One Pesos (P25,111,061.00)";
