**PROVINCIAL RESOLUTION NO. 565-2021**

**URGING ALL LOCAL GOVERNMENT UNITS OF THE PROVINCE OF PANGASINAN TO FURTHER INTENSIFY THEIR VACCINATION ROLL OUT PLAN IN THEIR RESPECTIVE LOCALITIES**

**WHEREAS**, the Local Government Code mandates local government units to exercise local autonomy and to ensure the general welfare of the people particularly in the promotion of their health and safety;

**WHEREAS**, Local Government Units (LGUs) are also mandated to take the lead in the implementation of the vaccination program, in accordance with the guidelines set by the national government;

**WHEREAS**, during this period of public health crisis, local government units are always in the forefront of the battle to curb the transmission of COVID-19;

**WHEREAS**, local government units play crucial roles in addressing and managing the crisis and in ensuring that the implementation of the COVID-19 vaccine roadmap will be effective and efficient;

**WHEREAS**, there is a need to facilitate a smooth implementation of a provincewide immunization program by simultaneously hitting the desired target population on time so as not to cause delay and have backlogs;

**WHEREAS**, local government units as grassroots implementers of the vaccination program shall hasten their inoculation drive to achieve the target herd immunity of the Province by the end of the year;

**WHEREAS**, considering the magnitude and urgency of the problem brought about by COVID-19, the Sangguniang Panlalawigan is seeking the help of local government units to protect the people against the dreaded disease by further intensifying their vaccination program and eventually put an end to the pandemic;
