**RESOLUTION NO. 57-2020**

**DECLARING ORDINANCE NO. 03-2019 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING OR PROVIDING ADDITIONAL PROVISION ON SECTION 3 OF ORDINANCE NO. 02-2002 OF THE MUNICIPALITY OF BURGOS, PROVINCE OF PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING THE SELLING OF CIGARETTES OR ANY KIND OF TOBACCO PRODUCTS, ALCOHOLIC LIQUORS OR INTOXICATING BEVERAGES TO MINORS AND IMPOSING PENALTIES FOR VIOLATIONS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Burgos, Pangasinan submitted its Ordinance No. 03-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the power of the Sangguniang Bayan to enact ordinances and approve resolutions carries with it the power to amend, revoke, modify or repeal the same;

**WHEREAS**, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of publication and posting pursuant to Sections 59 and 511 (a) of RA 7160;
