APPROVING MUNICIPAL RESOLUTION NO. 2019-95 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 FOR CALENDAR YEAR 2019 OF THE MUNICIPALITY OF ALCALA, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Alcala, Pangasinan submitted its Resolution No. 2019-95 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Alcala, Pangasinan has formulated the municipality's Supplemental Investment Program No. 2 for Calendar Year 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Executive Committee Resolution No. 2019-01 dated August 30, 2019. This was subsequently approved by their Sangguniang Bayan thru Resolution No. 2019-95 dated September 9, 2019. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 2 of the municipality with an investment requirement of P2,653,037.00 covers the fund augmentation for the disaster risk reduction management, personal services, maintenance and other operating expenses and implementation of new development projects not included in the approved 2019 AIP;
